#### BENEFIT ENROLLMEMENT & INCENTIVES

Did you know medical and dental plan enrollments or changes must be entered into the Benefitsolver website at <a href="https://my.state.nj.us/aui/Login?">https://my.state.nj.us/aui/Login?</a> If you enroll or enter a benefit change in the Benefitsolver system you may receive and alert to provide documentation for your dependents (birth certificates, social security cards, tax documents or marriage certificates). If you do not upload the requested documentation your eligible dependents will not be enrolled in your plan(s).

The Benefitsolver website has been designed as a portal with a means to communicate with plan participants. For this reason, it is a good ideal to go back to the Benefitsolver website and view any messages on your profile. The Benefitsolver system and the HR Benefits Team will also send you a reminder to submit outstanding documents.

Did you know that Horizon offers monetary incentives to assist you in your health goals?

- 1. With NJWell if you earn 800 points you can receive a \$250 visa a gift card.
- 2. If you enroll in the Horizon Omnia plan for one year you will receive a \$1,000 gift card.
- 3. Bfit will give you and your family members \$20 each month for completing 12 days of activity in a month.

Please note: These incentives are taxable benefits which will be applied at the end of the calendar year.

## **EDUCATION ASSISTANCE PROGRAM**

Did you know each year you are eligible to be reimbursed up to \$3,700 for educational assistance? Prior to the start of any course, academic credit by exam, seminar, or conference, submit an Educational Assistance Program Application to your supervisor if you have:

- Completion of one (1) year of continuous regular employment in a position working twenty (20) or more hours a week.
- Are in active pay status at the time of reimbursement which is upon receipt of your final grades.
- Current performance evaluation must be proficient or better.

## RUTGERS SCHOOL OF PUBLIC HEALTH AND HRSA

The Rutgers School of Public Health is encouraging individuals currently working in the field of public health in New Jersey to consider applying for a scholarship to obtain a Master's in Public Health (MPH) degree or a Certificate in Population Health.

Eligible applicants will receive a 50% tuition scholarship. #### **VOLUNTARY BENEFITS**

Did you know that **M3 Technology -** provides Hospital Employees that are actively working guaranteed acceptance (no physical or blood test required) for voluntary benefit plans paid through payroll deductions.

Universal Voluntary Life – Permanent Life Insurance coverage with a cash value that continues to grow.

Disability Insurance – Comprehensive disability policy that can provide financial protection during an illness.

Accident Insurance – Accident insurance will provide cash payments to you for a covered accident.

Critical Illness – Critical illness insurance will pay you a lump sum cash payment upon your diagnosis of a covered condition.
