

OPEN ENROLLMENT

Our Annual OPEN ENROLLMENT period will be from October 1st to October 31st. During this time, you can enroll or change your medical and dental plans (You must remain in a designated dental plan for twelve (12) months from the effective date of your coverage before you can change plans.) You can also open a [Flexible Spending Account \(FSA\)](#) for 2023. A personalized Total Compensation Statement has been prepared for you and mailed to your home address. This statement summarizes the value of your benefits package and will assist you in evaluating your coverage.
